OFFICIAL CONTEST RULES

- NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE WILL NOT IMPROVE YOUR ODDS OF WINNING.
- VOID WHERE PROHIBITED. ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS APPLY.

- 1. **Sponsor and Administrator**: Bruins Academy Flat Blades Challenge ("Contest") is sponsored and administered by Boston Professional Hockey Association, Inc. ("Sponsor").

All times in this Contest refer to Eastern Daylight Time. By participating, Entrants agree to be bound by these Official Rules and by all decisions of the Sponsor, whose decisions are at its sole discretion and are binding and final. Failure to comply with these rules will result in disqualification from this Contest.
